Der Hafen Mertert liegt am mittleren Abschnitt der kanalisierten Mosel, zwischen den Ortschaften von Mertert und Grevenmacher, mit einer Gesamtfläche von ca. 65 ha. Beide Kais entlang des Hafenbeckens, an welchen sich 11 rollende Kräne mit einer Hebekraft von 12 bis 124 Tonnen befinden, haben insgesamt eine Länge von 1.600m.




