EXECUTIVE SUMMARY

A turbulent vear lies behind us, as 2022 had its number of new challenges and opportunities. Russia's war of aggression on Ukraine, high uncertainties about China's political course, like the No-Covid policy impacting growth figures and the large impact of the energy crisis generating inflation, had a strong impact on competitiveness and creation of value in the sector. We are cautiously optimistic but see weaker developments ahead impacted by global developments.

Our customers and stakeholders, the industry and commerce, continued throughout the year, to face remarkable risks of disruptions. Those were impacted by strong imbalances in global supply chains and continuous pressure, at one time over 11% of global shipments were delayed in ports around the world.

SUPPLY CHAIN AND **LOGISTICS ARE WELCOME IN LUXEMBOURG**

Private and public investments into logistics infrastructure added more than 250'000 sam of warehouses since 2010. Ideally located in the heart of Europe less than 300 kilometres away from the world-leading maritime ports of Antwerp and Rotterdam. Its infrastructure and agile service providers offer access to service a market of 450 million consumers in less than 9 hours. It's an attractive spot for international value adding logistics activities for industry, retail and the growing European e-commerce sector.

Luxembourg is a top 10 international logistics location in Europe, strengthening the diversification of the economy with top freight villages and a focus on data-driven global supply chains.

RESILIENCE AND FLEXIBILITY ESSENTIAL FOR LOGISTICS SECTOR

Its stable political and economic business climate supports Luxembourg as a recognized location for resilient supply chain activities. The end of the COVID-19 pandemic created high economic volatility and supply chain disruptions explained by low capacity and bottlenecks across all transport modes. Astonishing resilience, e-commerce and stock arowths and restricted airfreight capacity pushed transport and logistics figures higher throughout 2022. Luxembourg ranked as the world's seventh most-connected country, in the Global Connectedness Index 2020 (GCI) by DHL. High requirements for flexibility to extreme demand for airfreight. road transportation and

rail freight was supported by industrial production across the alobe. Continued investments in infrastructure documented the confidence of the economy, as customers realized ever more, how essential a reactive supply chain activity is.



DRIVEN BY EU GREEN DEAL AND FIT-FOR-55

The multimodal transport continued its expansion by increasing destinations on the North range and East of Europe. The Fit-for-55 program announced in 2021 by the European Commission was reinforced by the energy crunch after the Ukraine invasion by Russia. Increased prices and lack energy of drivers provide good long-term attractiveness of Luxembourg if the countries across Europe invest enough to reinforce the capacities of the major traffic corridors. The Dudelange freight village is now regularly connected to Belgium, China, France, Germany, Italy, Poland, Spain, Scandinavia and Turkey.

The logistics zone Eurohub Center in Contern also expanded the number of players offering airfreight handling and contract logistics for healthcare, robots, retail, e-commerce and secured high value airfreight close to the airport. The high maritime container rates maintained a continued interest for companies serving Europe.

The C4L is a network of logistics companies and professionals with over 100 companies. The University of Luxembourg offers an academic Master in Logistics and Supply Chain Management to serve the talent needs for companies like Amazon, Ferrero or Vodafone.



A Logistics Briefing and the monthly "Logistics conversations" series podcast should explain and promote the professional image and create visibility.

DATA DRIVEN INNOVATION FOR SUPPLY CHAIN MANAGEMENT

Luxinnovation, the innovation agency, offered specific Fit 4 Resilience, Fit 4 Digital, Fit 4 Sustainability support programs to help companies make the switch. In particular, the programs help the needs of small and medium-sized enterprises (SMEs).

The strategy published in 2019 by the Ministry of the Economy is committed to data innovation and sustainable logistics. Attracting international conferences like the May 2022 European Freight Leaders allows company leaders to adapt their supply chain strategies.

A further reduction of CO₂ emissions to ambitiously fight climate change are addressed by the Lean and Green program in its 9th year. Clean fuels for heavy-duty transportation are increasingly expected for the sector to decarbonize, if coordinated incentives across Europe support the energy transition. Addressing shippers needs and the economic reality is key.

Cargolux comes out of this polycrisis reinforced allowing the airport to confirm its 5th position in Europe with over 1 million tons of airfreight. The Port of Mertert continued its traditional and trimodal freight offer reinforced by closer collaboration.

Luxembourg continues to focus on value adding activities, to serve a broad range of companies established in Luxembourg with competent talents, coming from different countries and cultures. The apprenticeship offers for logistics technicians (DT) and warehousing (DAP) should encourage companies to train new talents and to build a multi-lingual workforce to serve a pan-European market.

NETWORKING AND INNOVATION OPPORTUNITIES OFFERED TO SUPPLY CHAIN MANAGEMENT

The Cluster federates institutional and private actors around different competences.

Bringing together representatives from industry, logistics companies, shippers, research, academia strengthens the international European logistics and e-commerce hub. European transport policy insights are provided through the UECC and Luxembourg BVL Chapter.

Digitization and environmental transitions are in the roadmap for 2030.

MISSION & SURVEY

The Cluster for Logistics Luxembourg (C4L) was founded in 2009 with the aim of diversifying Luxembourg's financeheavy economy and developing the central and business-friendly location of Luxembourg as a logistics hub in the heart of Europe. After more than 10 years of existence, the thematic fields and core focuses of the Cluster for Logistics have been continuously adapted to the needs of the sector and today the 4 central pillars of action of the C4L can be divided into innovation, promotion, networking and knowledge sharing:

INNOVATION:

The C4L supports its members through offers in the field of digitalization and sustainability in order to drive them to innovate and to develop competitive and unique logistics capabilities.

PROMOTION:

The C4L represents the transport and logistics sector as well as its members on a national and international level, and thus strengthens Luxembourg's position as a competitive logistics hub in Europe.

NETWORKING:

The C4L promotes exchange among the various stakeholders from the logistics sector of the Greater Region across the boundaries of individual transport modes.

KNOWLEDGE SHARING:

The C4L serves its members as a neutral coordination, information and communication platform. Further, the C4L ensures the apprenticeship of young logistics students in the framework of the DT logistics program.



MISSION & BUSINESSPLAN

The Cluster for Logistics Luxembourg (C4L) as a logistics network is involved with administrations, logistics operators and shippers to drive forward priorities that are necessary for the development of Luxembourg as a competitive logistics hub in Europe. For this purpose, the C4L has identified the 4 central thematic areas of innovation, promotion, knowledge sharing and networking as the main priorities for driving future activities.

After preceding years were marked by the COVID-19 pandemic, 2022 added yet another crisis, since Russia invaded Ukraine in February 2022.

The invasion concluded in huge repercussions on global logistics, such as: food supply shortage and rising food prices, a rise in oil and gas prices, congested ports, container shortage, and surcharges.

Looking ahead, the current challenges of the logistics industry such as increased energy costs, high inflation, labour shortages and changing sustainability regulations will centrally influence the activities of C4L in the short and medium term. In this context, the Cluster for Logistics seeks to find fast solutions that can relieve the burden on its members. In the longer term, the Cluster will focus on the topics of sustainability and digitalization in logistics. In the field of sustainable logistics, we are aware of the importance of the Lean & Green program to help transport and logistics companies prepare for the sectoral climate targets and to quantify and, ideally, reduce their emissions in advance. In addition, our members will face enormous challenges in terms of digitization in order to optimize processes and maintain their competitiveness.

Therefore, in the future we will deal with digitalization models along the 4 transport modes we represent, to advise our members in the digital transition in the best possible way. Finally, while many industries, including logistics, are still suffering from labour shortages, the C4L plans to launch a new educational program in 2023 with the House of Training.

> INNOVATION: Continuation of digitalization and sustainability focus

Digitalization for process optimization & competitiveness The C4L continues putting a focus on digitalization in 2023. The starting point for the digitalization activities in 2023 are the results of the digitalization survey "C4L Member Survey on Digital Transformation in **Transport and Logistics"** which was organized in collaboration with the Ministry of the Economy. A summary and the most important conclusions of the survey can be found on page 10.



Digitalization & Sustainability The EU Green Deal with its new directives, the EU-Taxonomy and the Corporate Sustainability Reporting Directive

(CSRD) leads to a change in managing and reporting on sustainability. Against this background, a Lean & Green event focused on **digitaliza**tion as reporting support will be organized.

Support green solutions for transport and logistics while remaining technologically open A selection of solutions currently supported by the Cluster are Ecoliners, hydrogen and electrification. Pilot projects and financial support play important roles to enable a transition and to gain experience with new technologies.

DIGITAL TRANSFORMATION IN TRANSPORT & LOGISTICS SURVEY

In 2022, the Cluster for Logistics Luxembourg (C4L), in cooperation with the Ministry of the Economy, conducted an anonymous survey to understand the needs of transport and logistics companies in their digital transformation processes. The aim of the survey was to gain insights about the challenges and requirements of the companies to provide them with appropriate support programs in their digital transformation process.

The Cluster for Logistics currently counts more than 100 members, and from these 39 companies participated. The survey was conducted over a period of 5 weeks, starting on February 1, 2022 and ending on March 4, 2022.

> **PART 1:** Internal implementation of digitalization processes

> PART 2: Handling and processing of data

> PART 3: Excursus: Electronic delivery notes

RESULTS AND CONCLUSIONS FROM THE SURVEY

Results show that the main use case(s) for the digital transformation of transport and logistics processes are Tracking & Tracing and Transport Planning, followed by Digital Freight Documents.

In terms of main technologies, 21 companies have investigated the use of Advanced Analytics and Artificial Intelligence Solutions, and 18 companies have investigated Internet of Things based





Overall, the results of the survey show that **91% of participating companies actively drive digitalization projects.** While 91% of companies indeed actively drive digital transformation, the survey also inquired the **main barriers** for driving such processes. The survey results show that most companies (26) indicate that a lack of time/conflicting priorities are the main barrier, followed by a lack of internal expertise indicated by 13 companies.

Actions by the C4L: Against this background, the C4L will focus on providing tailored support to our members regarding identified digitalization priorities to save the time of doing their own research. Moreover, the C4L focuses on integrating digitalization expertise into school education: DT Logistique, Formation Responsible en Logistique etc.

TOP PRIORITIES OF SUPPORT INITIATIVES FOR C4L MEMBERS:

Moreover, the survey investigated what kind of support the companies would need to move forward in their digitalization efforts. The statistics show that knowledge sharing organized by industry associations (e.g., Digital Workshops, Conferences, etc.) and consulting support for developing digitalization projects (e.g., Luxinnovation) are the most prominent answers among participants, followed by start-up events (e.g., C4L Matchmaking Events).

Actions by the C4L: The C4L will organize digital workshops with experts on hot topics of digital transformation in logistics to react to the requests of the study participants. Furthermore, the Logistics Conversations podcast and newsletter will increasingly tackle topics around digital transformation. Besides this the C4L makes sure to maintain and expand Start-up Matchmaking events to the needs of our members.

64% have not benefited from support initiatives according to the survey results. Zooming in on the reason why companies have not benefited from support initiatives, 50% of companies say they have not been informed about existing initiatives. Followed by 23% of companies indicating that it is too much effort to benefit from the programs.

Actions by the C4L: To counteractalack of information, the C4L plans to develop joint information campaigns about support initiatives in the ecosystem by promoting initiatives by the Ministry of the Economy, Luxinnovation etc.

Besides insights on the implementation and use of digitalization processes, the survey inquired the handling and processing of data and electronic delivery notes. In terms of handling and processing of data, the survey results show that security and GDPR concerns are the key challenges that participating companies see in the collection and processing of data. Furthermore, the excursus on electronic delivery notes finds that 46% of responding companies work with some sort of electronic delivery note. However, companies stated a lack of harmonization between countries


and a lack of acceptance among business partners as the main reasons for not using electronic delivery notes yet.

The C4L will continue to support the implementation of electronic delivery notes in the future.

THE EUROPEAN TRANSPORT POLICY AND UECC ACTIVITIES 2022

The European policy on transport is influenced by the European commissions Green Deal launched by Ursula von der Leyen in 2019. Climate change and environmental degradation are an existentialthreattoEuropeand the world. To overcome these challenges, the European Green Deal should transform the EU into a modern, resourceefficient and competitive economy, ensuring:

> no net emissions of greenhouse gases by 2050

 economic growth decoupled from resource use

> no person and no place left behind

One third of the €1.8 trillion investments from the Next-GenerationEU Recovery Plan, and the EU's seven-year budget will finance the European Green Deal. The European Commission has adopted a set of proposals to make the EU's climate, energy, transport and taxation policies fit for reducing net greenhouse gas emissions by at least 55% by 2030, compared to 1990 levels.

The C4L has executed a mandate from the Union of Chambers of Commerce for transport and mobility (UECC) to lead the working group and establish public relations in Brussels from Luxembourg since 2021.

In 2022, the C4L director Malik Zeniti organized monthly calls of a working group to exchange news and answer in common to "have your say" proposals of the EU. A working group (WG) was created to address the last mile subject of "City or urban logistics" lead by Mrs Andrea Faast from Vienna. The first annual get together took place in Innsbruck on 12th and 13th May 2022 visiting the Brenner tunnel project on the Scan-Med TEN-T corridor to address the complicated situation of the traffic between the South of Germany, Tyrol in Austria and Italy with a specific resolution.

The second annual meeting of the UECC took place in Stuttgart in September to support the necessary expansion in length of locks on the river Neckar to transport goods in a most sustainable way by river navigation to the Rhine, as the investements were under threat. Numerous European requests for feed-back for new legal initiatives and directives of the European Commission and Parliament were addressed.

As outlook for 2023, the first meeting of the UECC in

4th October 2022 DT LOGISTICS BEST STUDENTS AWARDS

As a sign of appreciation and to boost the image of logistics in the public, the Cluster for Logistics (C4L) supports the best students of the "Dipôme de Technicien (DT) en Logistique" every year. On October 4th 2022, Claude Meisch, Minister of Education, Children and Youth and Carlo Thelen, Director General of the Chamber of Commerce and president of the C4L, honored two students for their outstanding achievements in their education.

In the school year 2021/2022, **Chiara Dewans**, a student at the Lycée Technique de Bonnevoie and employed by Arthur Welter Transports, and **Marvin Charpentier**, a student at the Lycée Technique de Lallange and employed by Sales-Lentz, made a name for themselves with outstanding achievements. The Cluster for Logistics Luxembourg honored the special talent and commitment of these two students by presenting the **DT Logistics Awards 2022**.

COOPERATION LEADS TO A SUCCESS STORY

Sixty graduates now have a "DT en Logistique". **"This training course is a success story,"** says Minister Meisch at the best students awards. "The training benefits from the commitment of motivated teachers and experts and the cooperation between the schools and the private sector guarantees that the training meets the expectations of the companies", according to



Minister Meisch. This approach enables positive results, as around 90 percent of those

who complete the training programme find a job straight away.

The shortage of skilled workers is also impacting transport and logistics companies, and the need for qualified employees will continue to increase in the coming years as baby boomers retire, according to Malik Zeniti, director of the C4L. The technician diploma can help companies find and retain these employees in the country. Not only truck drivers, but also dispatchers and warehouse managers are






in short supply throughout Europe. Luxembourg's companies therefore appreciate the logistics training and generally hire motivated trainees straight away.

The graduate training for technicians in logistics was introduced in 2015 with the help of the Cluster for Logistics Luxembourg and prepares young students for jobs such as the transport planification.


The "DT en Logistique" is offered by two schools at the moment: Lycée Technique de Bonnevoie, Lycée Technique de Lallange. Currently, it takes four school years to finish with a degree "DT en Logistique". The first year is purely at school and students are supposed to find a company for the next three years. The last three years contain 3 days at the company and 2 days at school per week.

Logistics and industrial companies need qualified and motivated young employees in order to fulfill the diverse tasks.

"The successful training of new talents in the field of logistics over the last few years sets the course for a positive development of the logistics industry in Luxembourg" welcomes Philippe Scholten, responsible for the "DT en Logistique" programme at the Cluster for Logistics Luxembourg in 2022. The area of responsibility of the trained qualified technicians includes, among other things, the planning and organization of transport, the management of warehouses and the implementation of customs clearance. Our logistics talents find jobs at over 700 companies such as freight forwarders, logistics companies, but also in industry or trade.

9th November 2022 6TH L&G AWARDS 2022

The Cluster for Logistics Luxembourg hosted the 6th edition of the Lean & Green Awards at the Luxembourg Chamber of Commerce. The Lean & Green Awards 2022 were awarded in presence of Mr Claude Turmes, Minister of Energy and Spatial Planning. At the Lean & Green Awards 2022, three additional companies were awarded for their efforts and achievements regarding the reduction of CO_2 emissions generated from transport and logistics activities.

TWO NEW CANDIDATES AND A 2 STAR WINNER

The Lean & Green programme welcomes a new 2 Star winner. **LuxairCARGO** managed to reduce its CO_2 consumption by more than 30 % compared to 2012. The company was a forerunner in the programme and received the label in 2015 and the first star award in 2018. Among



other measures, the company replaced their freezer units with more efficient models and installed modern lighting in the Cargocenter.

Furthermore, two companies have decided to join the Lean & Green initiative in Luxembourg in 2022. **Karp-Kneip** and **Eurogaume** have set up audited and eligible action plans that provide both companies the framework to reduce their CO_2 emissions from transport and logistics activities by at least 20% within the coming 5 years.

For the commitment of joining the programme and developing individual action plans to allow reducing greenhouse gas emissions, both companies were awarded the Lean & Green Label.

The president of the Cluster for Logistics, Carlo Thelen, says: "Especially, the energy-intensive transport and logistics sector. where fuel prices have doubled and can account for more than 50 % of the operating costs. has been hit hard by geopolitical developments in eastern Europe, Thus, these developments have shown how important it is for companies to understand their carbon footprint and drive sustainable transformation to reduce dependence on fossil fuels."

With rising energy prices and increasing sustainability requirements, companies are bound to reduce their CO₂ output. Minister Claude Turmes was glad to meet Lean & Green participants since such projects enhance energy efficiency. Interministerial groups for logistics in cooperation with Luxinnovation and the House of Startups are currently working on studies and projects for a better energy grid and charging infrastructure. A recent investment call





of 5 million euros allowed for 700 additional charging stations and a new call will be launched in January 2023. The ministry is working on a CO, tax exemption regime on HVO (Hydrotreated Vegetable Oil) for 2023. Plans also include a support regime for zero carbon trucks. A first hydrogen fuel station is being built in Luxembourg but the infrastructure in the Greater Region must also be strengthened.

The Lean & Green programme is a sustainable logistics initiative which is offered by the Cluster for Logistics Luxembourg, in collaboration with the Ministry of Mobility and Public Works, since 2014 in Luxembourg. Over the past 8 years, the Cluster for Logistics Luxembourg has already supported 16 companies in their sustainability efforts. The Lean & Green initiative envisions to induce companies to implement a set of self-defined optimization measures in order to reduce their CO_2 emissions linked to transportation and logistics activities by at least 20%. By taking a closer look at their logistics activities and rethinking their current business processes, the companies participating in the programme are able to identify potential for savings and optimization and, thus, to make the best use of their resources by saving costs (Lean) and reducing CO_2 emissions (Green).

F&L's European Freight Leaders network of senior business leaders met in Luxembourg – intercontinental logistics hub in the heart of the blue banana, and one of the world's largest steel producers. Participants were based across the European continent, in often global roles with global companies.

This meeting supported by the C4L and CFL mm enabled an exchange of ideas and possible solutions to today's challenges in an open and confidential environment with a wide community of logistics & supply chain leaders, experts, practitioners, thought-leaders and innovators.


